- Mary's Park Fence: the village refuses to repair the heaved sections. The HOA has funds to repair and needs proposals for repair costs. One estimate received by Pres. Martino was \$4,200 for the park (35 posts) and \$5,400 for homes (45 posts) to reset posts in dug holes then repair fence sections. A motion was made by Pres. Martino to approve repair of fence in the park for \$5,000, seconded by Treas. Delgado. Vote was 2 yes and 1 no (Sec. Hitschel). The motion was passed. A motion was made by Pres. Martino for the HOA to pay up to \$3,500 with a 50% contribution of adjacent property owners with 100% buy-in of all homeowners with payment received prior to work being initiated on their lots. The motion was seconded by Treas. Delgado. Vote was 2 yes and 1 no (Sec. Hitschel).

- Rental Policy: Policy states that lease copies and riders must be filed with the association. A motion to ratify the policy was made by Treas. Delgado, seconded by Pres. Martino, the motion passed unanimously. Copy attached.
