1625 Deep Lake Rd, Lake Villa, IL 60046 Proper maintenance of individual properties is essential to maintaining the look and character of the community. To restore and maintain the look, the Association is asking for your cooperation.

Many fences, mailboxes, and exterior of homes need repair, painting, and/or power washing. The Board has decided to implement a threephase approach to enforcement of the Association rules as they relate to the items mentioned.

<u>Phase 1</u>

The first phase is self-compliance. We ask that homeowners evaluate their existing fences, mailboxes, and exteriors to determine if maintenance or replacement is required. If so, we ask that you please make those repairs within 30 days of receiving this letter.

Phase 2

Beginning in August, Associa will begin to identify violations related to these maintenance items, in addition to those typically identified. An initial notice will be mailed to your home identifying the specific violation and providing you with 30 days to remedy the situation by making the specified repairs.

Phase 3

Beginning in September, residents who have failed to comply with the requests will begin receiving fines for improperly maintained fences, mailboxes, and/or exteriors, in accordance with the governing documents of the Association.

Mailboxes

The Architectural Review Committee has approved the following mailbox for installation within NeuHaven Homeowners Association:

White Gibraltar Mailbox on a Gibraltar Whitley Plastic Post. These mailboxes are manufactured by Gibraltar Mailboxes and support either 1 or 2 mailboxes. We recognize that many residents share a mailbox with their neighbor. If this is the case, please work directly with your neighbor to coordinate the replacement. Violations letters and fine will be sent to both addresses.
